The company, part of the regional group Waiken ILW, acquires Proxxima in the northeast of the country, achieving a strong presence in the states of Pernambuco, Paraíba, Bahia, Rio Grande do Norte, and Ceará.

São Paulo, November 24, 2025 – The Latin American telecommunications company Zaaz, part of the Waiken ILW Group, announces the acquisition of Proxxima, strengthening its strategic presence in the Brazilian market and expanding its operations in the states of Pernambuco, Paraíba, Bahia, Rio Grande do Norte, and Ceará.

With this deal, Zaaz consolidates its growth trajectory and adds an important regional asset, strengthening its position as one of the country's leading fiber optic internet providers. The integration of Proxxima will allow for an immediate expansion of the customer base and the expansion of high-speed, high-quality, and stable services.

Proxxima joins the Zaaz ecosystem with a highly qualified team, in-depth knowledge of the unique characteristics of the Northeast, and recognized operational capacity in the sector. This local experience will be key to accelerating expansion plans, strengthening regional presence, and increasing value delivery to customers. The talent, culture of consumer proximity, and commitment to operational excellence built by Proxxima are added to the values already present in the Waiken ILW Group, reinforcing a shared vision of innovation, quality, and customer focus.

The acquisition of Proxxima is part of Zaaz's regional expansion plan, which has been increasing its market share since 2023 and was recently recognized as one of the most innovative providers in the Brazil.



The acquisition is subject to regulatory approval. Its completion is subject to prior review by the Administrative Council for Economic Defense (Cade, for its acronym in Portuguese) and approval by the National Telecommunications Agency (Anatel, for its acronym in Portuguese), which must assess the potential impact on competition and on the operation resulting from the new corporate structure.
